TENTATIVE OUTAGE SCHEDULE

With the loss of four baseload generators, Cabras I & II, MEC Units No.,: 8 & 9, the Island Wide Power System is short of generation capacity to meet demand for electricity. As such the Guam Power Authority announces the following **tentative outage schedule for 7 September 2016 as needed and is subject to change depending on demand for power:**
